From the North and East: Take Rt. 287 South to exit 58 to Rt. 202, Ramapo Valley Road. Turn left at the light. Follow Rt. 202 South for three miles. Park is on the right. (Watch for low stone wall.)

Or, From the East: From GWB, Rt. 4 West to Rt. 208 North to Rt. 287 South. Take exit 58 to Rt. 202, Ramapo Valley Road. Turn left at the light. Follow Rt. 202 for three miles. Park is on the right.

From South and West: Take Rt. 287 North to Exit 53 (Bloomingdale/Pompton Lakes). Make right @ light (Hamburg Tpke.). Go to 5th light and make a left onto Terhune Drive (CVS on corner). Park is about one mile up the hill on the left. (Watch for low stone wall.)

Or, From South: Take GSP North to exit 153B to Rt. 3 West to Rt. 46 West to Rt. 23 North to (4 mi.) stay right Rt. 202 North (Black Oak Ridge Road). Wellesley on right. Continue to Hamburg Tpke. Turn left onto Hamburg Tpke. Turn right at light onto Terhune Drive (still Rt. 202). Park is one mile up the hill on the left.
