To be eligible for this award, a Collie must participate in at least three of the
fours AKC events offered by the CCA (Breed, Obedience/Rally, Agility or
Herding). Sign up for the award at any performance event. You must sign up
for the award to be eligible, and signup sheets must be turned in to Beth Elliott
by the end of the agility trial. The detailed rules for determining the winner
from the Collies that qualify for the award are given below. Note that weighting
factors are used in each of the performance events to recognize the increased
difficulty of the higher level classes. In the Non-Best of Variety classes, points
are awarded based on the number of dogs defeated in the class. All scores will
be recorded from the posted Judge's sheets. Beth Elliott will maintain the offi-
cial scores at this show. The award presentations will be announced on Satur-
day, April 24, 2021 in the main conformation ring. (Time TBA).

Rules for the Most Versatile Collie Award

To be eligible for this award, your Collie needs a qualifying score in at least three
of the four AKC events at the National Specialty. A collie that receives MVC
points in Breed is considered to have received a qualifying score in that event.
Only one score will be counted for each event. The Collie obtaining the highest
point total will win the award. The following scoring system will apply:

BREED:

- All Collies that are a conformation champion or have at least 5 Championship points will receive a minimum of 40 MVC points for entering and showing in a conformation class at the CCA National.
- Collies with less than 5 Championship points will not automatically receive any MVC points for showing in a conformation class. Points will only be awarded for placing in a class and defeating competition.
- Since this is an individual award, Brace Class performances do not count. No points will be awarded to Collies entering a conformation class and not showing (i.e. marked absent).
- In the BOV class and Winners competition, points will be awarded as follows:

Making no cuts:	40 points	Reserve Winners:	75 points
Making first cut:	50 points	Winners:	80 points
Making second cut:	60 points	Best of Winners:	85 points
Making third cut:	70 points	Best of Opposite Sex:	90 points
Awards of Merit:	80 points	Best of Variety:	100 points
Select Dog or Bitch:	85 points		
- In all other conformation classes, points will be awarded based on the number of dogs defeated in that class as follows:
- No placement: 40 points for Conformation champions and Collies with 5 or more CH points, 0 points for Collies with less than 5 CH points.
- Placements: Two (2) additional MVC points are awarded for every dog defeated in the class up to a maximum total number of 70 MVC points. (Collies with less than 5 CH points will also receive the base 40 MVC points for placing and defeating dogs in a class.)

Herding Judges Biographies

Carol Ann Hartnagle

Carol Ann Hartnagle is the third of four Hartnagle generations to enjoy a lifetime association with working stock dogs. From the time she was a child, she saw and used Australian Shepherds in the environment for which they were originally intended. Her family's bloodline, Hartnagle's Las Rocosa Aussies was founded in 1955. She is the breeder, trainer and handler of a number of advanced working titled Australian Shepherds and has titled in all areas of competition.

A multidisciplined judge in AKC and ASCA Carol Ann has been invited to judge in more than 35 states and seven countries and has received the honor of judging National Specialties for a number of parent clubs. She has presented training seminars all across North America, UK, and Europe.

As one of the first approved AKC Herding Program Judges, Carol Ann has also assisted and coached a number of trial and ranch participants to successfully achieve their goals. She recently co-authored a popular book entitled The Total Australian Shepherd—Beyond the Beginning with her father, Ernest Hartnagle.

Terry Kenney owned and operated a herding training facility, Task Farms, in Leona Valley, CA since February 2000. At Task Farms he has trained multiple breeds of dogs and hosted nine or ten herding trials a year. Although he has earned titles on multiple breeds for clients, he most frequently worked with border collies, the breed that he breeds and owns himself. Terry also raised cattle for a while and often worked them with his horses and dogs. He retired two years ago and moved to Cheyenne, Wyoming to be near his daughter and granddaughter. He is actively training herding dogs at a ranch in Colorado.



Judging Schedule

CCA Herding Tests and Trials April 16-17, 2021

The first handler's meeting will be at 8:00 am both days. Judging will start at 8:30 am both days with a handlers' meeting prior to each class as desired by exhibitors and judges. There will be a lunch break at the judges discretion. Other breaks mid-morning and mid-afternoon are at the judges' discretion.
